

The regular meeting of the Greenville City Council was called to order by Mayor Hoppough, in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville, Michigan 48838 at 7:30 p.m.

Present: Mayor Hoppough; Councilpersons Lehman, Cunliffe, Warner, Scoby, Moss Schuleit, and; City Manager Bosanic; Clerk-Treasurer Hool; City Engineer Hinken; Public Safety Sgt. Brian Blomstrom.

Absent: None.

Councilperson Lehman MOVED: The Consent Agenda be approved as presented. Councilperson Schuleit seconded. Unanimously adopted.

The Consent Agenda consisted of the following:

1. Approval of minutes for the regular City Council meeting held February 16, 2016.
2. Approval of payroll report for regular pay period February 12, 2016 in the amount of \$111,414.42. Approval of accounts payable report for pay period ending February 25, 2016 in the amount of \$268,848.29.

Council considered the approval of a Municipal Support to Montcalm County Basic Plan.

Councilperson Lehman MOVED: To approve the proposed Municipal Support to Montcalm County Basic Plan as presented. Councilperson Moss seconded. Unanimously adopted.

Council considered the approval of a resolution to accept Forest View Drive into the City's street system.

Councilperson Moss MOVED: To approve resolution No. 16-04, a resolution for the addition of Forest View Drive into the City's public street system as presented.

WHEREAS, the Forest View Townhomes and Forest View Duplexes have deeded a recently upgraded street to the City of Greenville known as Forest View Drive.

AND WHEREAS, it is necessary to furnish certain information to the State of Michigan to place this street within the City of Greenville public street system for the purpose of obtaining funds under Act 51, P.A. 1951 as amended.

NOW THEREFORE IT IS RESOLVED: That the center line of said street is described as: A strip of land, beginning 60-feet wide, in the Northeast ¼ of Section 8 and the Southeast ¼ of Section 5, T9N, R8W, City of Greenville, Montcalm County,

Michigan as shown and referenced in the Master Deeds for Forest View Townhomes, as recorded in Liber 1271, Pages 1266 to 1322; and Forest View Duplexes, as recorded in Liber 1272, Pages 9 to 73, in the office of the Montcalm County Register of Deeds with centerline described as: Commencing at the Northeast corner of Section 8; thence S1°25'33"W, 188.99 feet, along the East line of the NE ¼ of said Section 8; thence S30°45'55"W, 174.39 feet; thence continuing S30°45'55"W, 122.75 feet; thence S59°14'05"E, 42.02 feet; thence S0°00'00"E, 107.52 feet, to the North right of way line of Greenville West Drive; thence Northwesterly 297.62 feet, along the North right of way line of Greenville West Drive, along a 759.20- foot radius curve to the left, the chord of which bears N83°17'32"W, 295.72 feet; thence S85°28'40"W, along the North right of way, 172.58 feet; thence S05°04'10"E, 58.16 feet to the Point of Beginning; thence N05°04'10"W, 145.06 feet; thence 45.14 feet along a 400-foot radius curve to the right, the chord of which bears N01°50'10"W, 45.12 feet; thence N01°23'49"E, 278.64 feet to a point of reduced width of 50-foot wide; thence continuing N01°23'49"E, 42.29 feet; thence 245.76 feet along a 450-foot radius curve to the left, the chord of which bears N14°14'54"W, 242.71 feet; thence N29°53'38"W, 74.74 feet; thence 20.91 feet along a 250-foot radius curve to the right, the chord of which bears N27°29'53"W, 20.90 feet to the Point of Ending of this description.

1. That said street is located within the City of Greenville right of way and is under the control of the City of Greenville.
2. That said street is a public street and is for public street purposes.
3. That said street is accepted into the City of Greenville Local Street System and was open to the public on December 31, 2015.

Councilperson Schuleit MOVED: To approve resolution No. 16-05 a resolution for the addition of Trail View Drive into the City's public street system as presented.

WHEREAS, the Forest View Duplexes has deeded a recently upgraded street to the City of Greenville known as Trail View Drive.

AND WHEREAS, it is necessary to furnish certain information to the State of Michigan to place this street within the City of Greenville public street system for the purpose of obtaining funds under Act 51, P.A. 1951 as amended.

NOW THEREFORE IT IS RESOLVED: That the center line of said street is described as: A 50-foot wide strip of land in the Northeast ¼ of Section 8, T9N, R8W, City of Greenville, Montcalm County, Michigan as shown and referenced in the Master Deed for Forest View Duplexes, as recorded in Liber 1272, Pages 9 to 73, in the office of the Montcalm County Register of Deeds with centerline described as: Commencing at the Northeast corner of Section 8; thence S1°25'33"W, 188.99 feet,

along the East line of the NE ¼ of said Section 8; thence S30°45'55"W, 174.39 feet; thence continuing S30°45'55"W, 122.75 feet; thence S59°14'05"E, 42.02 feet; thence S0°00'00"E, 107.52 feet, to the North right of way line of Greenville West Drive; thence Northwesterly 297.62 feet, along the North right of way line of Greenville West Drive, along a 759.20 foot radius curve to the left, the chord of which bears N83°17'32"W, 295.72 feet; thence S85°28'40"W, 172.58 feet, along the North right of way; thence N05°04'10"W, 86.90 feet; thence 45.14 feet along a 400 foot radius curve to the right, the chord of which bears N01°50'10"W, 45.12 feet; thence N01°23'49"E, 278.64 feet to the Point of Beginning; thence N88°36'11"W, 250.37 feet; thence 78.54 feet along a 50-foot radius curve to the right, the chord of which bears N43°36'11"W, 70.71 feet; thence N01°23'49"E, 95.57 feet; thence 128.08 feet along a 125-foot radius curve to the right, the chord of which bears N30°45'06"E, 122.55 feet; thence N60°06'22"E, 161.68 feet to the Point of Ending of this description.

1. That said street is located within the City of Greenville right of way and is under the control of the City of Greenville.
2. That said street is a public street and is for public street purposes.
3. That said street is accepted into the City of Greenville Local Street System and was open to the public on December 31, 2015.

Councilperson Cunliffe seconded. Unanimously adopted.

Council considered the approval of a resolution to accept Viewpoint Drive into the City's street system.

Councilperson Moss MOVED: To approve resolution No. 16-06 a resolution for the addition of Viewpoint Drive into the City's public street system as presented.

WHEREAS, the Forest View Townhomes has deeded a recently upgraded constructed street to the City of Greenville known as View Point Drive.

AND WHEREAS, it is necessary to furnish certain information to the State of Michigan to place this street within the City of Greenville public street system for the purpose of obtaining funds under Act 51, P.A. 1951 as amended.

NOW THEREFORE IT IS RESOLVED: That the center line of said street is described as: A 50-foot wide strip of land in the Northeast ¼ of Section 8, T9N, R8W, City of Greenville, Montcalm County, Michigan as shown and referenced in the Master Deed for Forest View Townhomes, as recorded in Liber 1271, Pages 1266 to 1322, in the office of the Montcalm County Register of Deeds with centerline described as: Commencing at the Northeast corner of Section 8; thence S1°25'33"W, 188.99 feet, along the East line of the NE ¼ of said Section 8; thence S30°45'55"W, 174.39 feet; thence continuing S30°45'55"W, 122.75 feet; thence S59°14'05"E, 42.02 feet; thence S0°00'00"E, 107.52 feet, to the North right of way line of Greenville West Drive; thence Northwesterly 297.62 feet, along the North right of way line of Greenville West Drive, along a 759.20 foot radius curve to the left, the chord of which bears N83°17'32"W, 295.72 feet; thence S85°28'40"W, 172.58 feet, along the

North right of way; thence N05°04'10"W, 73.47 feet to the Point of Beginning; thence 416.25 feet along a 1200-foot radius curve to the left, the chord of which bears S73°54'54"W, 414.17 feet to the Point of Ending, said point also being the center of a 42.50-foot radius circle to form a cul-de-sac.

1. That said street is located within the City of Greenville right of way and is under the control of the City of Greenville.
2. That said street is a public street and is for public street purposes.
3. That said street is accepted into the City of Greenville Local Street System and was open to the public on December 31, 2015.

Councilperson Schuleit seconded. Unanimously adopted.

Councilperson Lehman MOVED: The meeting be adjourned. Councilperson Cunliffe seconded. Unanimously adopted.
