

The organizational meeting of the Greenville City Council was called to order by Clerk-Treasurer Hool in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville MI 48838 at 7:00 p.m.

Councilpersons present: Hoppough, Cunliffe, Lehman, Greene, Moss and Scoby.

Councilpersons absent: Schuleit (excused).

Others present: City Manager Bosanic and Clerk-Treasurer Hool.

The first order of business was the election of Mayor for the ensuing year.

Councilperson Moss MOVED: Councilperson Hoppough be nominated for Mayor. Councilperson Cunliffe supported.

Councilperson Lehman MOVED: The nominations for Mayor be closed. Councilperson Cunliffe supported.

Unanimous votes were cast to elect Councilperson Hoppough as Mayor.

Mayor was sworn in.

The second order of business was the election of Mayor Pro-Tem for the ensuing year.

Councilperson Cunliffe MOVED: Councilperson Schuleit be nominated for Mayor Pro-Tem. Councilperson Moss supported.

Councilperson Lehman MOVED: The nominations for Mayor Pro-Tem be closed. Councilperson Hoppough supported.

Unanimous votes were cast to elect Councilperson Schuleit as Mayor Pro-Tem.

Council considered setting the meeting schedule for the year.

Councilperson Scoby MOVED: To establish City Council meetings for 2015 on the first and third Tuesday of each month, and cancel the regular meeting for July 7<sup>th</sup> as presented. Councilperson Lehman supported. Unanimously adopted.

Council considered the appointment of City Council representatives to Committees, Commissions and Boards.
