

The regular meeting of the Greenville City Council was called to order by Mayor Hoppough, in the Council Chambers, in the Municipal Complex, located at 415 S. Lafayette Street, Greenville, MI 48838 at 7:30 p.m.

Present: Mayor Hoppough; Councilpersons Cunliffe, Lehman, Greene, Schuleit, Moss and Scoby; City Manager Bosanic; Assistant City Manager VanWyangarden; and Clerk-Treasurer Hool.

Absent: None.

Councilperson Scoby MOVED: The Consent Agenda be approved as presented. Councilperson Moss supported. Unanimously adopted.

The Consent Agenda consisted of the following:

1. Approval of minutes for the regular City Council meeting held February 21, 2012.
2. Approval of payroll report for pay period ending February 19, 2012 in the amount of \$122,667.13.
3. Approval of accounts payable report for period ending February 24, 2012 in the amount of \$268,048.99.
4. Approval of minutes for the regular Planning Commission meeting held January 26, 2012.

Council considered the approval of the proposed Poverty Guidelines and Maximum Asset Standards.

Councilperson Lehman MOVED: To approve the proposed Federal Poverty Guidelines Maximum Asset Standards as presented. Councilperson Greene supported. Councilpersons Hoppough, Cunliffe, Lehman, Greene, Schuleit and Moss concurred. Councilperson Scoby did not concur. Motion passed.

Council considered a request for closure of the Fred Meijer Flat River Trail in connection with the 4<sup>th</sup> Annual Tour DeDonut.

Councilperson Lehman MOVED: To approve the request for closure of the Fred Meijer Flat River Trail for the 4<sup>th</sup> Annual Tour DeDonut Race to be held September 22, 2012 as presented with the provision that Mr. Klackle remove all existing markings made for the previous event by May 1, 2012 as presented. Councilperson Scoby supported. Unanimously adopted.

Council considered a request to use the Fred Meijer Flat River Trail from Habitat for Humanity in connection with the Spin the Spokes for Habitat – Pedal for People event.

Councilperson Lehman MOVED: To approve the request from Habitat for Humanity to use the Fred Meijer Flat River Trail on Saturday, May 19, 2012 from 7:00 a.m. to 4:00 p.m. for a fund raising event as presented. Councilperson Schuleit supported. Unanimously adopted.

Council considered setting special meetings.

Councilperson Cunliffe MOVED: To set a special meeting with the Planning Commission for Tuesday, March 13, at 6:30 p.m. and a special meeting to discuss Items for Accomplishment for Tuesday, March 19, at 6:00 p.m. Councilperson Lehman supported. Unanimously adopted.

Council considered entering into Executive Session.

Councilperson Lehman MOVED: Council enter into Executive Session. Councilperson Moss supported. Unanimously adopted.

Councilperson Moss MOVED: The regular meeting reconvene. Councilperson Lehman supported. Unanimously adopted.

Council considered approving a contract with MR Valuation LLC to conduct an appraisal of the Uni-Solar Facilities.

Councilperson Lehman MOVED: To approve the proposed contract with MR Valuation Consulting LLC of Colts Neck New Jersey in the amount of \$75,000 plus travel expenses for appraisal services as presented. Councilperson Scoby supported. Unanimously adopted.

Councilperson Moss MOVED: The meeting be adjourned. Councilperson Cunliffe supported. Unanimously adopted.
