

The regular meeting of the Greenville City Council was called to order by Mayor Hoppough, in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville, Michigan 48838 at 7:30 p.m.

Present: Mayor Hoppough; Councilpersons Schuleit, Lehman, Greene, Moss; City Manager Bosanic; Acting Deputy Clerk Foster; City Engineer Hinken; Public Services Director Pollock.

Absent: Cunliffe and Scoby (excused).

Councilperson Schuleit MOVED: The Consent Agenda be approved as presented. Councilperson Lehman seconded. Unanimously adopted.

Council considered approving a request from Danish Festival, Inc. to close certain street in connection with the 2015 Annual Danish Festival.

- Grove Street from Clay Street to Franklin Street – August 20, 2015 at 5:30pm to 9:00am August 23, 2015.
- Hillcrest Street from Blackburn to Cass Street; Cass Street from Hillcrest Street to Franklin Street; Franklin Street from Cass Street to Montcalm Street; Montcalm Street from Franklin Street to Clay Street; Clay Street from Montcalm Street to Cass Street; Cass Street from Clay Street to Hillcrest Street; Hillcrest Street from Cass Street to Blackburn Street – August 21, 2015 at 7:30pm to 10:00pm.
- Hillcrest Street from Blackburn Street to Cass Street; Cass Street from Hillcrest Street to Clay Street; Clay Street from Cass Street to Montcalm Street; Montcalm Street from Clay Street to Hillcrest Street and Bower Street from Cass Street to Montcalm Street – August 22, 2015 at 9:00am to 2:00pm.
- Southbound land of Marvel Drive to Baldwin Lake Drive to South Street August 20, 2015, 8:45 to 10:00pm.

Council considered a request for temporary use of City parking from Gladding Properties, LLC in regards to a renovation dumpster.

Councilperson Lehman MOVED: To approve the request to reserve 3 parking spaces identified on the enclosed map on the south side of East Cass Street adjacent to the building located at 300 North Lafayette Street from May 6th, 2015 to August 1st, 2015 for the purpose of locating a dumpster and other related renovation equipment as presented. Councilperson Greene seconded. Unanimously adopted.
