

CITY COUNCIL PROCEEDINGS

May 20, 2014

The regular meeting of the Greenville City Council was called to order by Mayor Hoppough, in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville, Michigan 48838 at 7:30 p.m.

Present: Mayor Hoppough; Councilpersons Schuleit, Cunliffe, Greene, Moss, and Lehman; City Manager Bosanic; Clerk-Treasurer Hool.

Absent: Councilperson Scoby.

Councilperson Lehman MOVED: The Consent Agenda be approved as presented. Councilperson Greene seconded. Unanimously adopted.

The Consent Agenda consisted of the following:

Council considered approving a request from Danish Festival, Inc. to close certain street in connection with the 2014 Annual Danish Festival.

Councilperson Lehman MOVED: To approve the request to close the following streets for the annual Danish Festival as presented. Councilperson Schuleit seconded. Unanimously adopted.

- Cass Street from Lafayette Street to Clay Street – July 17, 2014 at 5:00pm to 11:30 am July 18, 2014.
- Lafayette Street from Washington Street to Montcalm Street – August 14, 2014 at 5:30pm to 9:00am August 17, 2014.
- Cass Street from Franklin Street to Clay Street – August 14, 2014 at 5:30pm to 9:00am August 17, 2014.
- Cass Street from Irving Street to Franklin Street and Franklin Street from Cass Street to Montcalm Street – at 5:30pm August 15, 2014 to 6:30pm, August 15, 2014.
- Grove Street from Clay Street to Franklin Street – August 14, 2014 at 5:30pm to 9:00am August 17, 2014.
- Hillcrest Street from Blackburn to Cass Street; Cass Street from Hillcrest Street to Franklin Street; Franklin Street from Cass Street to Montcalm Street; Montcalm Street from Franklin Street to Clay Street; Clay Street from Montcalm Street to

Cass Street; Cass Street from Clay Street to Hillcrest Street; Hillcrest Street from Cass Street to Blackburn Street – August 15, 2014 at 7:30pm to 10:00pm.

- Hillcrest Street from Blackburn Street to Cass Street; Cass Street from Hillcrest Street to Clay Street; Clay Street from Cass Street to Montcalm Street; Montcalm Street from Clay Street to Hillcrest Street and Bower Street from Cass Street to Montcalm Street – August 16, 2014 at 9:00am to 2:00pm.
- Southbound lane of Marvel Drive from Baldwin Lake Drive to South Street- August 14, 2014 at 8:45pm to 10:00 pm.

Council considered the awarding of a bid for communication maintenance for City communication equipment.

Councilperson Moss MOVED: To award a three-year contract for maintenance of City communication equipment to Crouch Communications, Inc. of Saranac, Michigan in the amount of \$24,213.60 as presented. Councilperson Greene seconded. Unanimously adopted.

Council considered a request for relief from the City’s nuisance ordinance from the Relay for Life Organization.

Councilperson Lehman MOVED: To approve the request from the American Cancer Society to grant relief from the City’s Noise/Lighting section of the Nuisance Ordinance for 10:00 am June 13, 2014 to 10:00 am June 14, 2014 at the Greenville Public Schools High School in connection with the Relay for Life fundraising event as presented. Councilperson Schuleit seconded. Unanimously adopted.

Councilperson Lehman MOVED: The meeting be adjourned. Councilperson Cunliffe seconded. Unanimously adopted.
