

The regular meeting of the Greenville City Council was called to order by Mayor Hoppough in the Council Chambers, in the Municipal Complex which is located at 415 S. Lafayette Street, Greenville Michigan 48838.

Present: Mayor Hoppough, Councilpersons Cunliffe, Lehman, Greene, Schuleit, Moss and Scoby; City Manager Bosanic; Assistant City Manager VanWyngarden; Clerk-Treasurer Hool; City Engineer Hinken and Code Enforcement Office Lillie.

Absent: None.

Councilperson Scoby MOVED: The Consent Agenda be approved as presented. Councilperson Lehman supported. Unanimously adopted.

The Consent Agenda consisted of the following:

1. Approval of minutes for the regular City Council meeting held September 18, 2012.
2. Approval of payroll report for regular pay period ending September 16, 2012 in the amount of \$158,314.67. Approval of accounts payable report for period ending September 24, 2012 in the amount of \$686,141.60.
3. Approval of minutes for the regular Economic Development Corporation meeting held July 5, 2012. Approval of minutes for the regular Planning Commission meeting held August 23, 2012.
4. Approved the proposed Michigan Municipal League Liability and Property Pool ballots.

A public hearing was held to receive comment on establishing an Industrial Facility District from M57 Brew Pub.

Councilperson Lehman MOVED: Council approves the request to establish an Industrial Facility District for the M57 Brew Pub property as presented. Councilperson Greene supported. Unanimously adopted.

A public hearing was held to receive comment on an Industrial Facilities Tax Exemption application from M57 Brew Pub.

Councilperson Scoby MOVED: To approve the Industrial Facilities Tax Exemption application from M57 Brew Pub as presented. Councilperson Moss supported. Unanimously adopted.

Council considered the approval of a license to occupy an area 16 feet in diameter for the purpose of constructing and subsequent maintenance of a gazebo on the Fred Meijer Flat River Trail above the Baldwin Lake Beach Trail Head.

Councilperson Moss MOVED: To grant a license to occupy an area 16 feet in diameter for the purpose of constructing and subsequent maintenance of a gazebo on the Fred Meijer Flat River Trail as described and presented. Councilperson Schuleit supported. Unanimously adopted.

Council considered the approval of a bid for installation of landscape items for the Museum parking lot.

Councilperson Lehman MOVED: To award a bid for the purchase and installation of landscape items for the Museum Parking Lot to ProLawn Inc. of Greenville, Michigan in the amount not to exceed \$7,191.84 as presented. Councilperson Moss supported. Unanimously adopted.

Council received an update on the Mersen Annexation request from the City Manager.

Councilperson Greene MOVED: The meeting is adjourned. Councilperson Cunliffe supported. Unanimously adopted.
