

The organizational meeting of the Greenville City Council was called to order by Clerk-Treasurer Rasmussen in the Council Chambers, in the Municipal Complex located at 415 S. Lafayette Street, Greenville MI 48838 at 7:00 p.m.

Councilpersons present: Hoppough, Cunliffe, Lehman, Warner, Moss, Schuleit, and Linton.

Councilpersons absent: None.

Others present: City Manager Bosanic and Deputy Clerk Hatfield-Grace.

The first order of business was the election of Mayor for the ensuing year.

Councilperson Cunliffe MOVED: Councilperson Hoppough be nominated for Mayor. Councilperson Schuleit supported.

Councilperson Moss MOVED: The nominations for Mayor be closed. Councilperson Cunliffe supported.

Unanimous votes were cast to elect Councilperson Hoppough as Mayor.

The second order of business was the election of Mayor Pro-Tem for the ensuing year.

Councilperson Moss MOVED: Councilperson Schuleit be nominated for Mayor Pro-Tem. Councilperson Warner supported.

Councilperson Moss MOVED: The nominations for Mayor Pro-Tem be closed. Councilperson Linton supported.

Unanimous votes were cast to elect Councilperson Schuleit as Mayor Pro-Tem.

Council considered setting the meeting schedule for the year.

Councilperson Moss MOVED: To establish City Council meetings for 2018 on the first and third Tuesday of each month, and cancel the regular meeting for July 3rd as presented. Councilperson Schuleit supported. Unanimously adopted.
